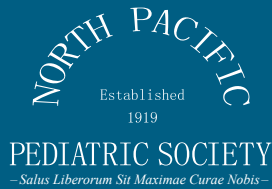

MEETING OBJECTIVES:

- Increase familiarity with safety, efficacy, and tolerability of ADHD medications and dose response relationships
- Describe how ADHD in parents affects children and vice versa,
- Increase awareness of ADHD mimics and associated problems and
- Describe developmental differences in ADHD treatment response,
- Identify ethical issues in mild or subclinical ADHD and how to approach
- Properly interpret and respond to failed CCHD screening
- Understand what congenital heart diseases are screened for and what diseases can be missed.
- Recognize when protracted bacterial bronchitis occurs in children
- Recognize reasons for airway mucus retention in children



- Know the different approaches to treat acute asthma in different children of different ages with asthma
- Anticipate variation in treatment response among children with asthma with different phenotypes
- Become familiar with the spectrum of normal adolescent growth development
- Learn about an efficient and structure interview to both determine strengths of an adolescent as well as uncover high risk behavior
- Provide three elements of LGBTQ competent care
- Practice gender-affirming care to gender non-conforming youth
- Diagnose common acute and overuse injuries in youth athletes
- Manage initial treatment or understand referral timing for these injuries
- Provide overview and update of 2016 Berlin consensus on sports concussion
- Recognize signs and symptoms of concussion, understand their management of concussion including return to learn and play.
