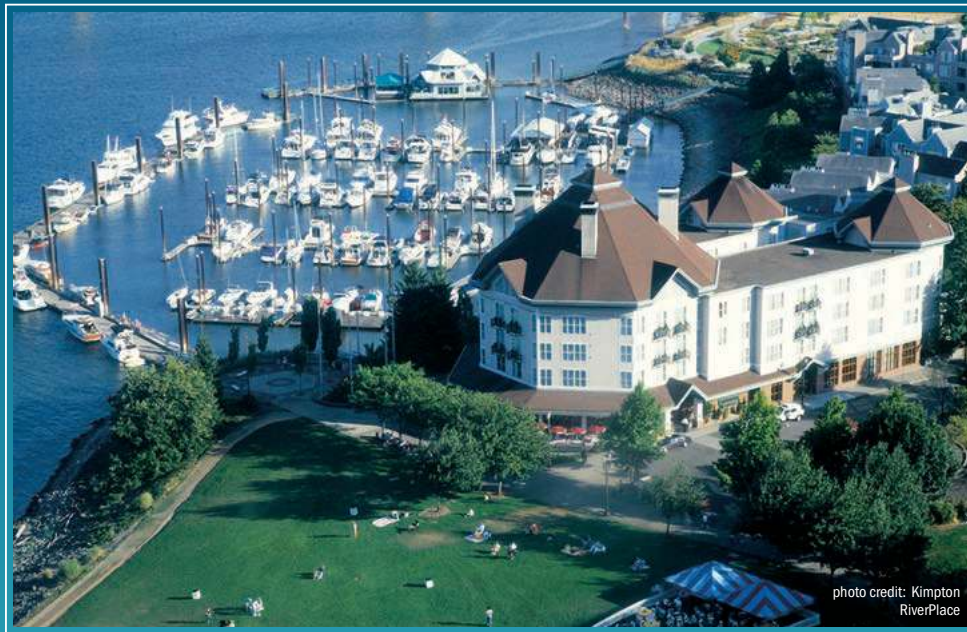
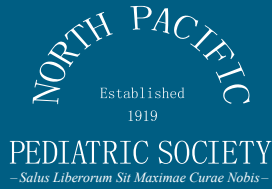

MEETING OBJECTIVES:

- Be able to distinguish between premature thelarche, premature adrenarche and true precocious puberty.
- Recognize when puberty is late or too slow and perform the correct initial evaluation.
- Make thinking about growth a part of your everyday practice when seeing children.
- Understand which patients small for age need to see a Pediatric Endocrinologist.
- Recognize the origins of vaccine hesitancy.
- Contrast rationale decision making process with how most immunization decisions are made.
- Appraise your office's current immunization practice and communication strategy.
- Understand that there are limited hypnotic medication studies in children.
- Review pharmacology of commonly used off label medications.
- Strategize with families about appropriate medication use and discontinuation.
- Understand the impact of adverse childhood experiences on health and wellness.
- Understand practical strategies for incorporating social determinants of health into primary care practice.
- Identify 4-5 common presenting signs of childhood cancer.
- Identify disease processes which childhood cancer mimics and have way to distinguish benign illnesses from potential malignancy.
- Name at least one method of determining whether a melanocytic neoplasm in a young patient is melanoma.
- Know the pitfalls of sentinel node biopsy in young patients.
- Understand pediatric urgent care, it's role in patient care, benefits
- Feel empowered to implement evidence based procedural interventions in your own practice
- Describe disaster vulnerability in the Pacific Northwest and current gaps in pediatric preparedness.
- Highlight the link between personal and professional disaster preparedness, and the importance of planning before a disaster occurs.
- Identify several straightforward steps that pediatricians can take to improve their personal and professional disaster preparedness.
- Understand the historical and sociopolitical origin of race and racism in the US and how it relates to at least three forms of racism.
- Recognize, define and give examples of microaggressions.
- Understand how white fragility can perpetuate a negative learning environment for underrepresented trainees, faculty, staff, and patients alike.
- Apply practical strategies for responding to and coping with microaggressions at both the individual and institutional levels.
- Identify advances in prenatal genetic testing and screening
- Recognize new genetic testing modalities
- Identify key concepts and issues inherent in models for vaccine Identify 3-4 reasons parents do and do not vaccinate and discuss 2-3 recommendations for future interventions aimed at increasing vaccinations.
